The Pendleton Business Pride Award was created to honor those businesses located within the city limits of Warren, Ohio who exemplify superior ethical, moral, and professional standards in their workplace while supporting the economic and community development of the City of Warren.

QUALIFICATIONS

- ☞ Nominees must have a physical presence in the City of Warren.
- ☞ Nominees must be from the for-profit sector.
- ☞ Nominees must be in good standing with the Better Business Bureau, be in compliance with all Warren City Ordinances, and be current on all fees, utilities, and taxes.
- ☞ Previous Pendleton Business Pride Award nominees are eligible for re-nomination.
- ☞ Previous Pendleton Business Pride Award recipients are *not* eligible for re-nomination.
- ☞ Nominees are not required to be members of the Regional Chamber or any other civic, service, or professional organization.

NOMINATION PROCEDURE

- ☞ Any person may nominate a business located within Warren city limits.
- ☞ Candidates may self-nominate.
- ☞ All nomination forms should be completed as thoroughly as possible, so as to ensure a comprehensive profile.

- ☞ The recipient of the award will be sent a confirmation letter prior to the event.
