Nomination Form

Qualifications:

- The nominee must have a physical presence in the Canfield area.
- The nominee may be in the for-profit or not-for-profit sector.
- Previous Canfield Business Pride Award nominees are eligible for re-nomination.
- The nominee is not required to be a member of the Regional Chamber but is strongly encouraged to be a member.

Nomination Procedure:

- Anyone may nominate a Canfield business.
- Candidates may self-nominate.
- Complete the nomination form as thoroughly as possible to ensure a comprehensive profile of your nominee.

- Nominees are strongly encouraged to assist in completing the form.

Selection and Recognition Process:

- The Selection Committee is comprised of Regional Chamber members in good standing who serve on the Canfield Area Council.
- Nominees may not serve as members of the Selection Committee in the year they are nominated.
- The award will be presented annually at the October Good Morning, Canfield/Area Council event.
- The recipient's name will be added to the permanent award, which will be displayed prominently in the community.
- The recipient of the award and the nominator will be sent confirmation letters prior to the event.
