



Technology Investment Tax Credit

Overview	Offers a variety of benefits to Ohio taxpayers who invest in small, research and development and technology-oriented forms.
Benefits	Provides a tax credit for taxpayers that invest in small, Ohio-based technology companies. The amount of the tax credit is 25% (or 30% in some limited cases) of the amount invested by the taxpayer. The maximum investment to which this credit may be applied is \$250,000 (or \$300,000). The credit may be claimed against personal income tax, commercial activity tax, public utility excise tax or the dealers in intangibles tax.
Eligibility	<ul style="list-style-type: none">- Businesses primarily focused on research and development, technology transfer, or the application of a new technology.- Business must have gross revenues less than \$1 million, or net book value of less than \$1 million, at the end of most recent fiscal year.- Principal place of business and 1/2 of its gross assets and employees must be in Ohio.- Business must have received less than \$1 million in investments that have qualified for the tax credit.
Rate/Terms	Investors may reduce their state taxes by up to 25% of amount invested.
